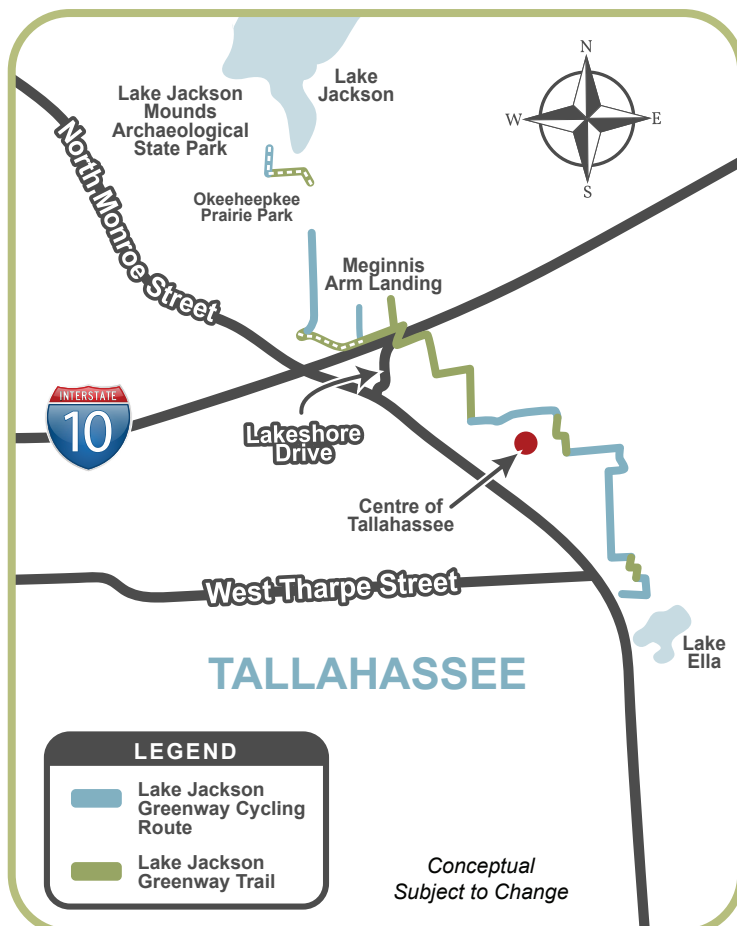

PROJECT GOALS

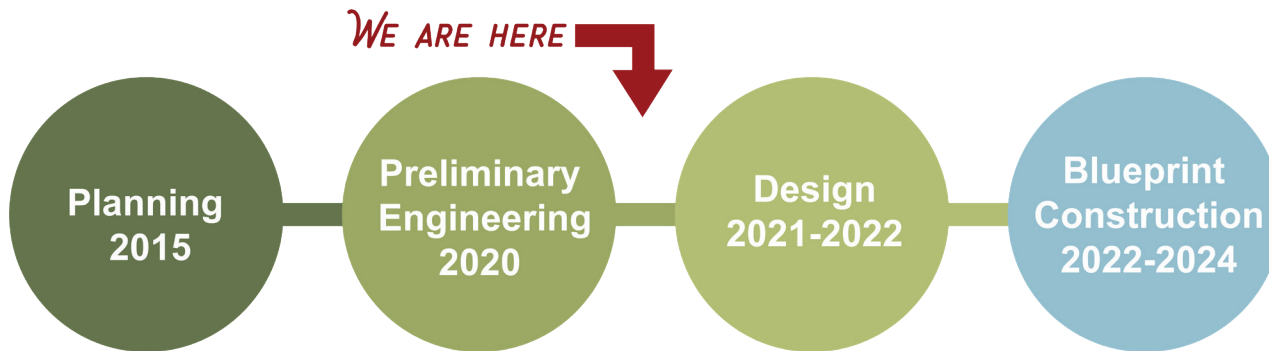
- ▶ Expand regional bike and pedestrian mobility.
- ▶ Provide connectivity from Lake Jackson Mounds Archaeological State Park to Lake Ella at Fred O. Drake Park.
- ▶ Connect public spaces and recreational, residential, and commercial areas to meet the needs of diverse population of users.
- ▶ Promote multi-modal safety and safe bicycle/pedestrian crossings.

PROJECT INFORMATION

The Lake Jackson Greenway project was originally conceptualized in the 2015 Tallahassee-Leon County Greenways Master Plan and will include a combination of natural surface trail, paved trail, and on-road designated cycle routes. Proposed amenities include the addition of a paddlecraft launch and improved parking at Meginnis Arm Landing.

Features will include intersection safety treatments, nature based education and wayfinding signage, and site furnishings. Major points of connection include Lake Jackson Mounds Archaeological State Park, Okeeheepkee Prairie Park, Fuller Landing, Meginnis Arm Landing, Sugar Creek Plaza, the Centre of Tallahassee, Trousdell Gym & Aquatic Center, and Fred O. Drake Park at Lake Ella in Midtown.

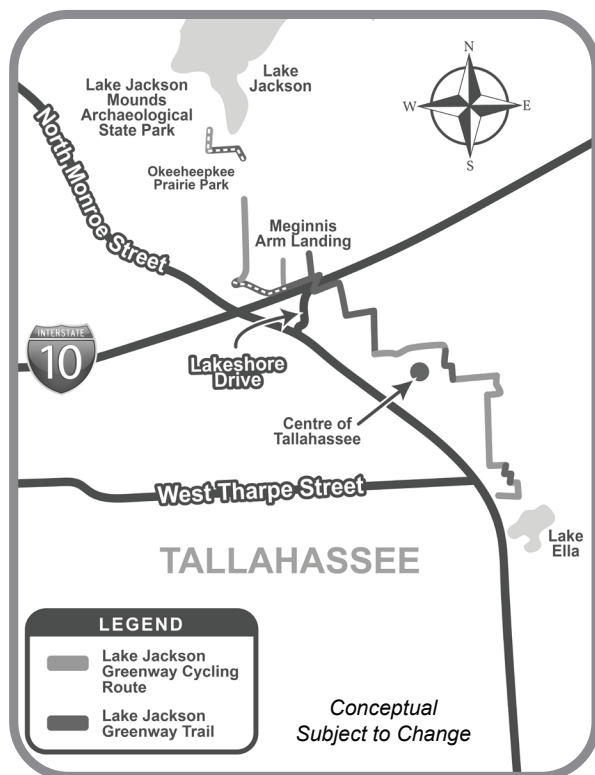
