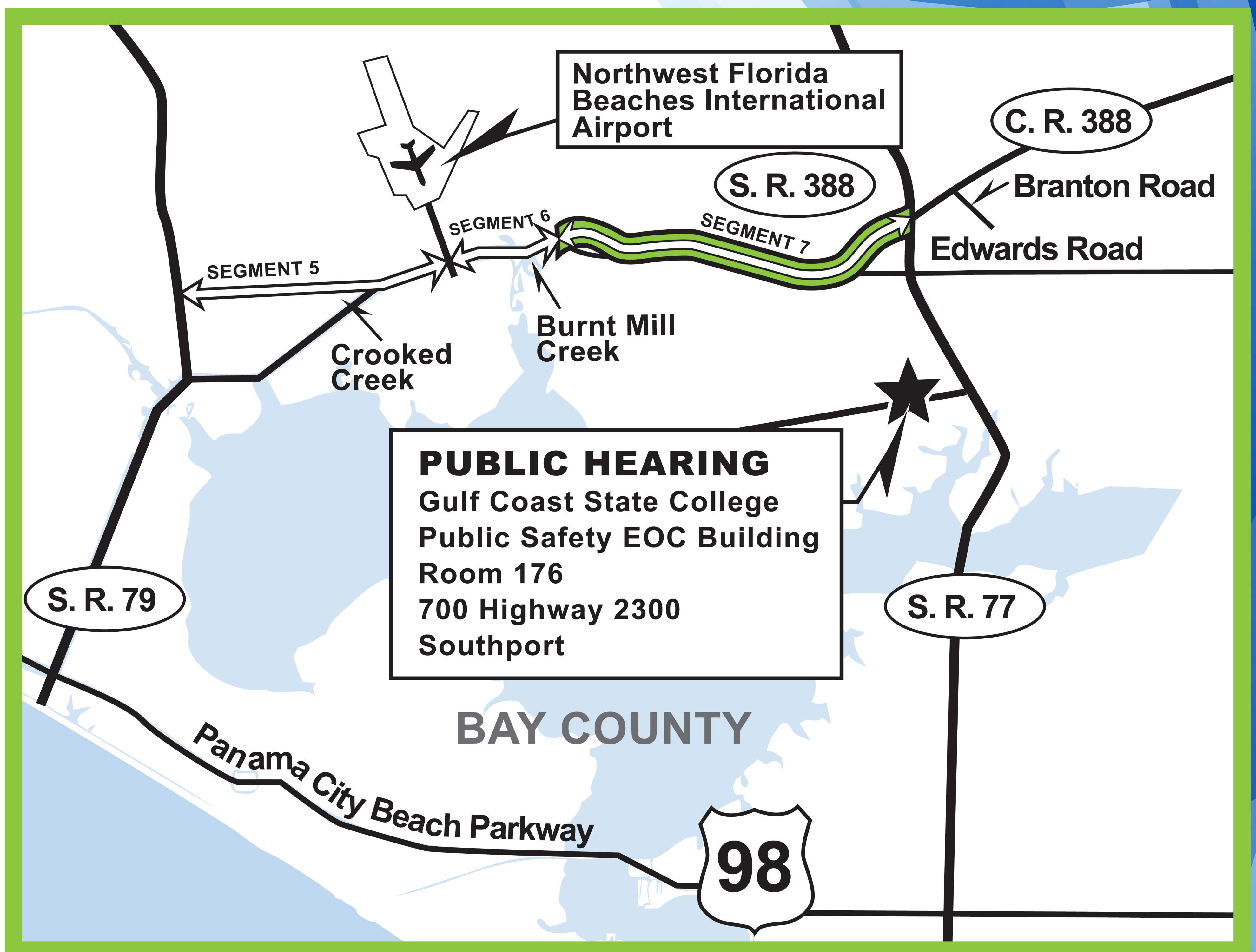

The eastern 1.5 miles of the project will realign S.R. 388 northward to intersect with S.R. 77 at County Road (C.R.) 388 and a cul-de-sac will be constructed on existing S.R. 388 approximately one mile west of the existing S.R. 388 intersection at S.R. 77 and Edwards Road. Right-of-way and construction are not funded in the current FDOT Five-Year Work Program.

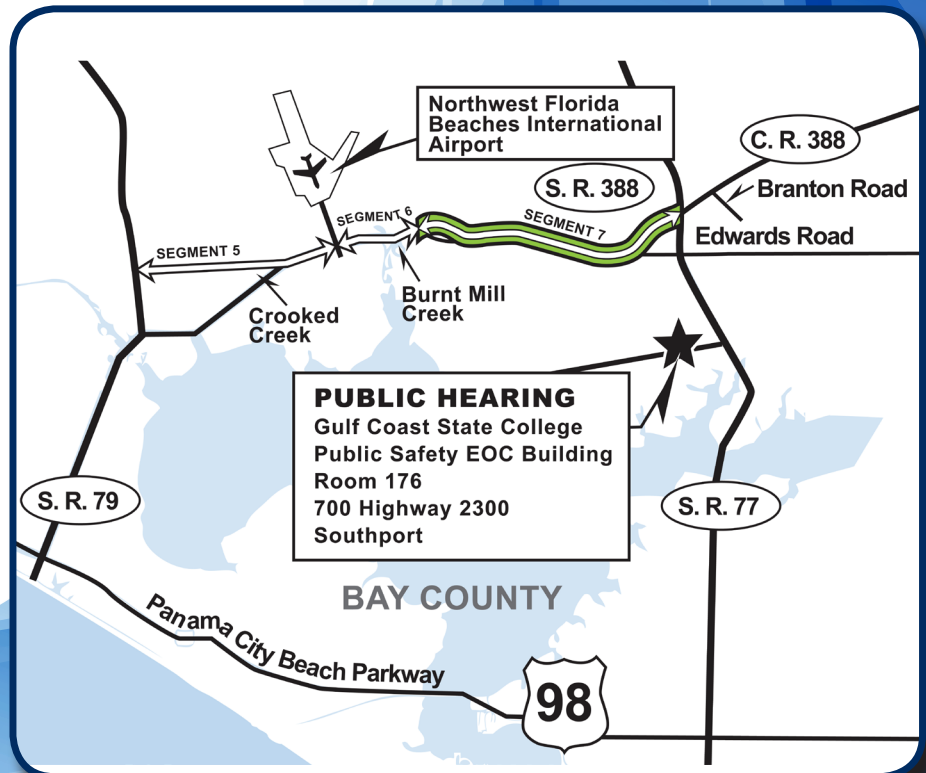

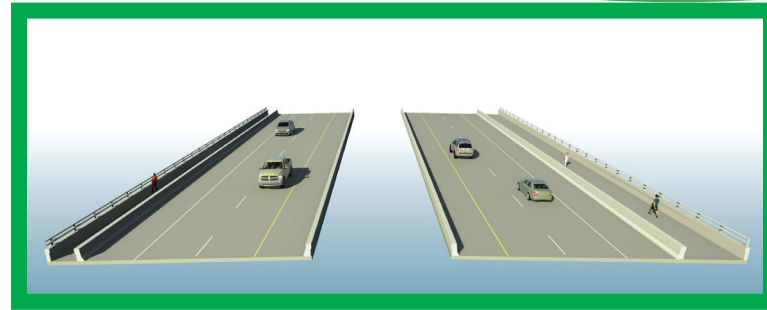

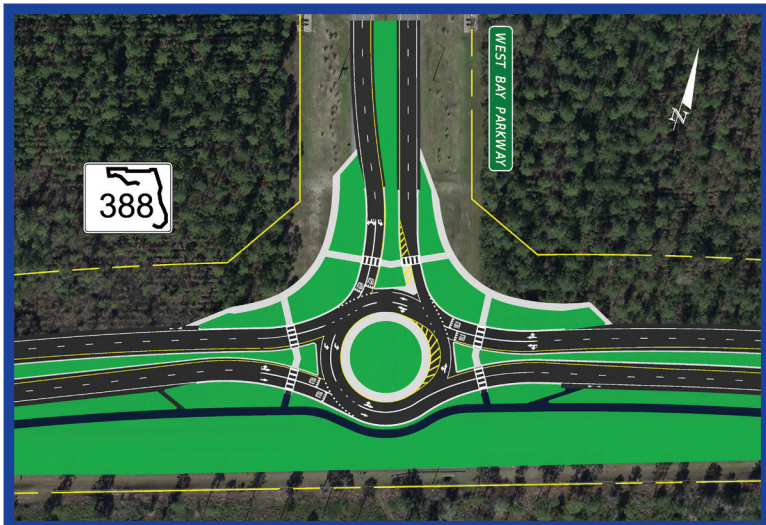

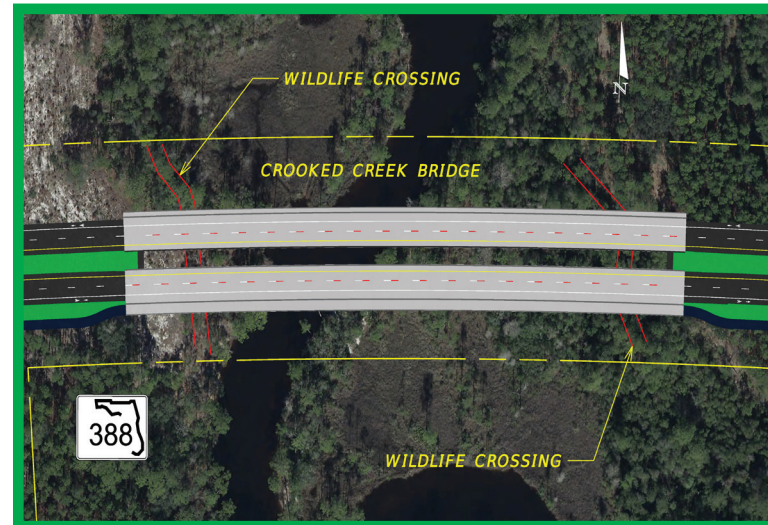


### Crooked Creek and Burnt Mill Creek Bridges Typical Section:

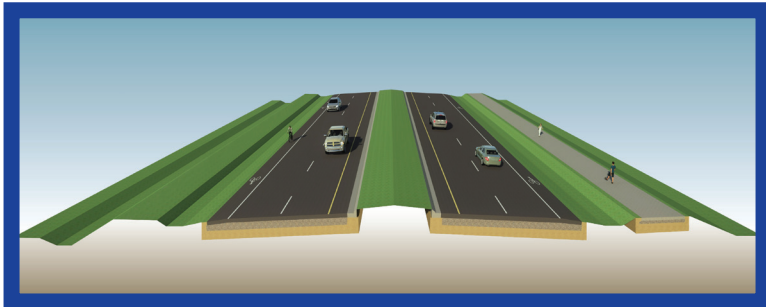

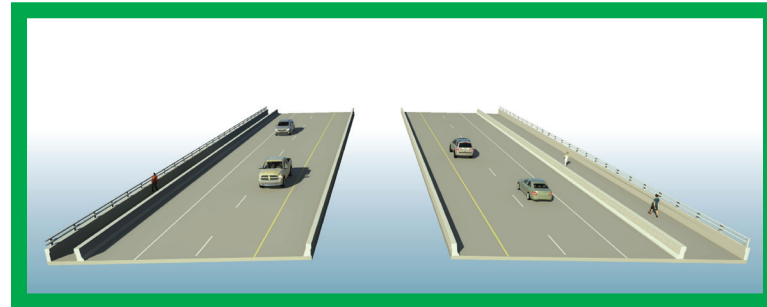
