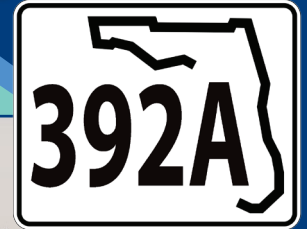
Project Information:

The intent of this project is to resurface the existing travel lanes and auxiliary lanes on S.R. 392A (Hutchison Boulevard) from U.S. 98A (Front Beach Road) to U.S. 98A (Front Beach Road). Additional improvements include improving drainage at the westbound right turn lane on S.R. 392A onto Richard Jackson Boulevard, repairing pavement failures attributed to drainage problems, adding sidewalks along the south side where the sidewalk does not exist, upgrading sidewalks to meet current Americans with Disabilities Act (ADA) access requirements, and improving traffic signals at the Panama City Beach Fire Department and Clarence Street. Bids for construction are scheduled to occur fall 2021.

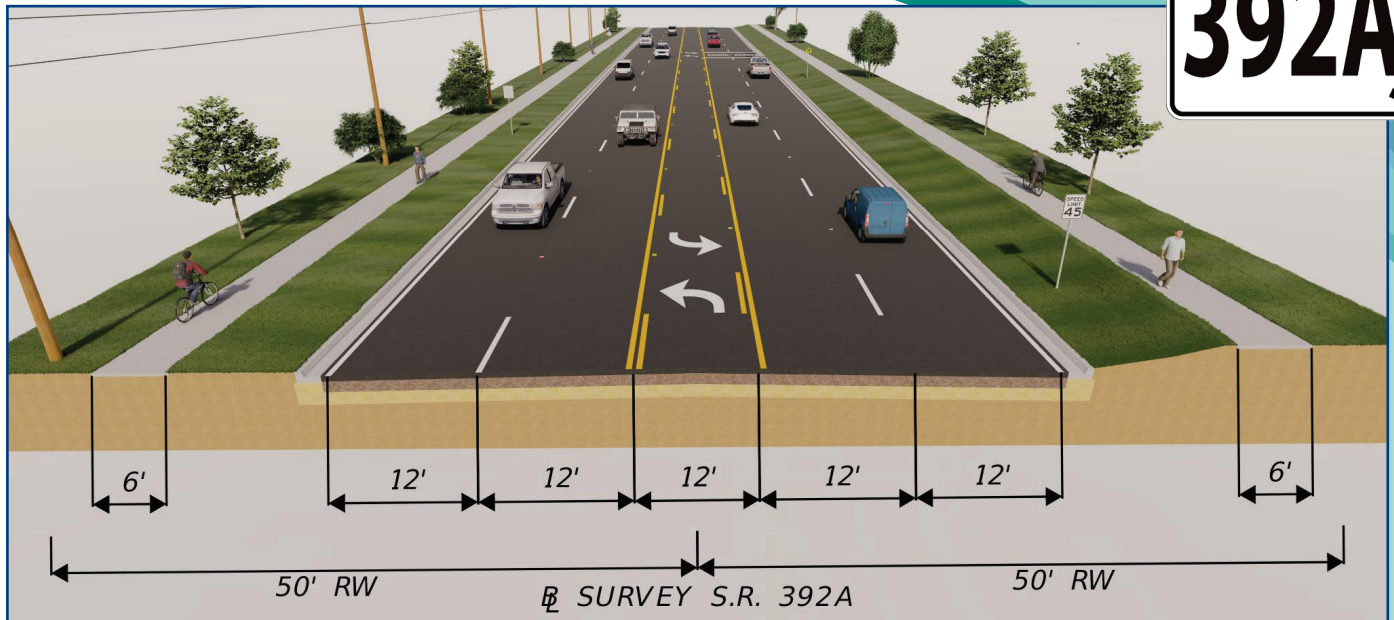

- Two twelve-foot wide travel lanes and concrete sidewalk in each direction
- Center two-way left turn lane

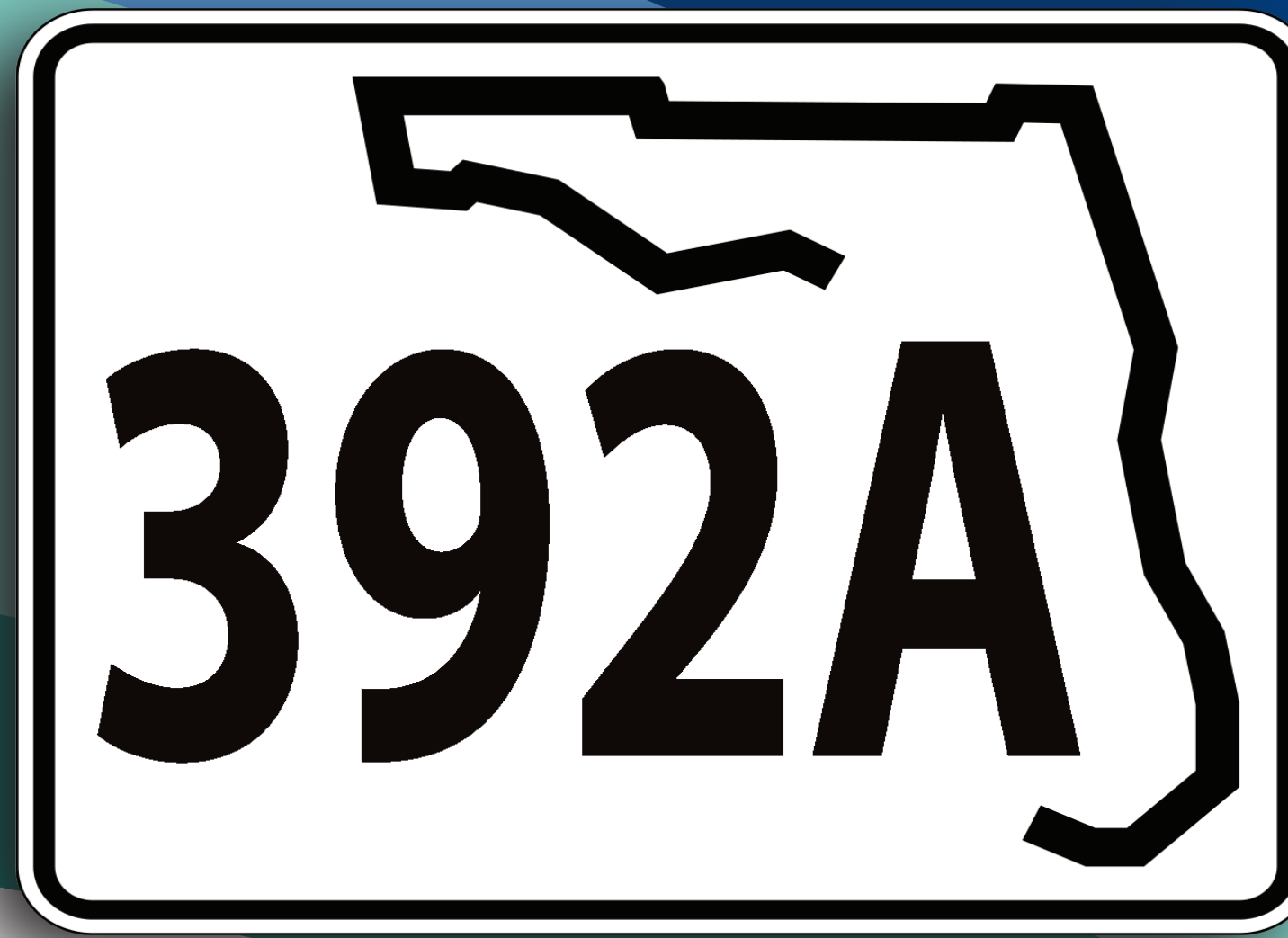

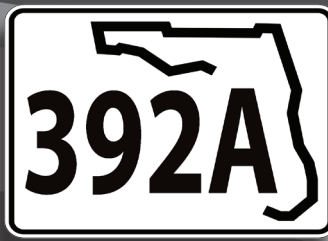

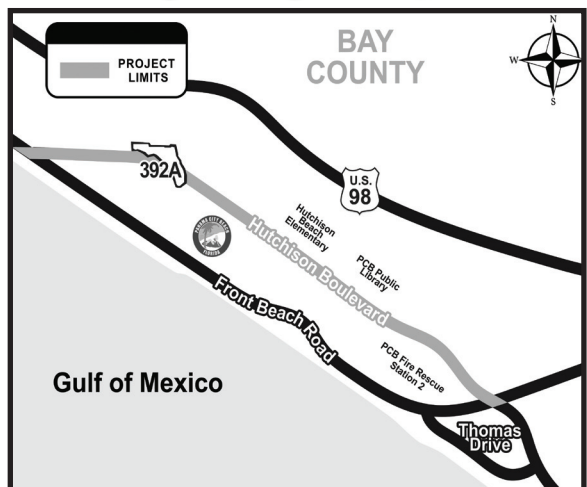
