


PROPOSED IMPROVEMENTS

Public input will be sought and considered throughout this process and the proposed improvements will be evaluated against the no-build alternative.




SUBURBAN TYPICAL SECTION


U.S. 98 from west of Walton County Line to the east end of the Phillips Inlet Bridge, and Carillon Avenue to Heather Drive - A 6-lane roadway with flush outside shoulders, raised grassed median, 6-foot concrete sidewalk, and a 10-foot multi-use path.



Phillips Inlet Bridge - Two new bridge structures with 6 12-foot travel lanes, 10-foot outer shoulders, 6-foot sidewalk, and a 14-foot multi-use path.



U.S. 98 from the east end of the Phillips Inlet Bridge to Carillon Avenue - A 6-lane roadway with curbed shoulders, raised grassed median, 6-foot concrete sidewalk, and a 10-foot multi-use path.



U.S. 98 from Heather Drive to S.R. 79 - A 6-lane roadway with curbed outside shoulders, raised grassed median, 6-foot concrete sidewalk, and a 10-foot multi-use path.



- ➤ U.S. 98 from east of Richard Jackson Boulevard to the Hathaway Bridge (FPID# 217838-5-52-01)




The Florida Department of Transportation (FDOT) is conducting a Project Development and Environment (PD&E) Study to analyze the existing characteristics, evaluate the community needs and impacts, and develop proposed conceptual improvements. This study will evaluate adding capacity on U.S. 98 by widening the roadway from four to six lanes from west of the Phillips Inlet Bridge to S.R. 79 (South Arnold Road) in Bay County. U.S. 98 is a critical east/west roadway and serves as a hurricane evacuation route. The total distance of this study is approximately 7.3 miles.

A PD&E Study is the formal process that develops and compares alternatives to determine a preferred action that meets project goals, while minimizing impacts to the social, natural, and physical environments. Engaging the public by sharing and receiving information is a key component of this process and required by the National Environmental Policy Act.

Over the next several months, FDOT will collect and analyze data to help develop project alternatives. A virtual project update will be held to provide interested persons the most current information on the project and allow additional opportunity for public input. 




